In Loving Memory

We are deeply saddened by the death of our Hon'ble Board Member Khondkar Ibrahim Khaled, former Deputy Governor of Bangladesh Bank. The veteran banker breathed his last in the early hours of 24th February 2021 at the age of 80 while undergoing post-COVID treatment at Bangabandhu Sheikh Mujib Medical University (BSMMU). He left behind his wife, a son, a daughter and a host of relatives and well-wishers to mourn his death.

Ibrahim Khaled was born on July 4, 1941 in Gopalganj. After obtaining Masters in Geography and MBA from IBA of Dhaka University, he joined the banking profession in 1963 and had been passionately associated with the sector for nearly six decades till his death. He was the Deputy Governor of Bangladesh Bank from 1998 to 2001. He was the Managing Director of Pubali Bank Limited for the 2001-2006 period. He also served in Bangladesh Krishi Bank, Agrani Bank and Sonali Bank as Managing Director. Lastly, he was appointed in Pubali Bank Limited as an Independent Director.

Ibrahim Khaled was a legendary banker having proven success records in directing the country's central and commercial banks as well. As Deputy Governor of Bangladesh Bank, he has set the example of stringently regulating the banking industry. Similarly, when he was leading commercial banks as CEO, he proved his worth in successfully running profit-making commercial banks strictly complying with rules, regulations and laws. The people of this country will forever remember him for his outstanding contribution to the overall development of the banking sector of Bangladesh.

Apart from making a direct contribution to the development of the banking system of the country, he also engaged himself in many welfare activities by being associated with a number of social development organizations.

He liked the company of children and teenagers even in his busy schedule. Until death, he was the Director of the Central Kachi-Kanchar Mela, President of the Executive Council and a Member of the Board of Trustees.

Khondkar Ibrahim Khaled was awarded the 'Khan Bahadur Ahsanullah Gold Medal' in 2009 and the 'Khan Bahadur Nawab Ali Chowdhury National Award' in 2013 for his outstanding contribution to the banking sector. In 2011, he was awarded Honorary Fellowship by Bangla Academy.

Khondkar Ibrahim Khaled served as an active Member of the Governing Board of the Human Development Foundation from the year 2000 to till his death with utmost devotion and sincerity. We will always remember with gratitude the role he had played, both directly and indirectly, in the progress of the Foundation. We pray to the Almighty for the peace of his departed soul and also convey our condolences to his bereaved family members.



In Memory of Prof. Dr. Nazma Chowdhury

We are deeply saddened by the passing away of our General Body Member Prof. Dr. Nazma Chowdhury, Emeritus Professor of Dhaka University and Adviser to the former Caretaker Government. Dr. Nazma breathed her last on August 8, 2021 at 7.30 a.m. while undergoing post-Covid treatment at a hospital in Dhaka at the age of 79. She is survived by two daughters and numerous well-wishers.

Dr. Nazma Chowdhury was born to Amirunnesa Khatun and Engineer Chowdhury Imamuzzaman in Sylhet on 26th February 1942. Her early schooling was in Assam, then in British India. She passed SSC from Kamrunnesa Girls' School, Dhaka in 1956 and stood 8th among girls in the East Pakistan Secondary Education Board. She passed her HSC from Holy Cross College, Dhaka and also stood 9th in the merit list of East Pakistan Higher Secondary Education Board. Dr. Nazma Chowdhury completed her graduation and post-graduation in Political Science in 1961 & 1962 respectively from Dhaka University. She joined the department as a lecturer in 1962. In 1972, she obtained her PhD from the University of London.

After completion of her PhD She returned to Bangladesh and joined in the Dept. in 1973. She was the Chairman of the Department of Political Science from 1974 to 1986. During her tenure in the department, she introduced courses related to women's empowerment and development into the curriculum. Dr. Nazma Chowdhury served as a visiting scholar at the University of Minnesota in 1988 under a Fulbright Fellowship for three months. She played a vital role in establishing the Women and Gender Studies department at DU in 2000. She served the department as the founding Chairperson for three years.

and 1986. During this time she also attended the UNESCO General Conference in Belgrade in 1980, the World Conference on Women in Nairobi in 1985, and the Fourth World Conference on Women in Beijing in 1995.

In 1996, she was appointed Adviser to the caretaker Government of Bangladesh. She was in charge of the Ministry of Women and Children Affairs, the Ministry of Social Welfare and the Ministry of Labor and Employment.

She was a friend of political scientist Barbara J. Nelson. The duo edited a book **Women and Politics Worldwide** in 1994. The book won the **Victoria Schuck Award** in 1995. She was honoured "Rokeya Chair" in 2007 by University Grants Commission (UGC) and received 'Ekushey Padak' for her outstanding contribution to research in 2008.

In private life, Nazma Chowdhury got married to Mainur Reza Chowdhury in 1981. Mainur Reza Chowdhury was a former Chief Justice of Bangladesh.

To be mentioned here that Dr. Nazma Chowdhury was one of the sponsor members of the Foundation and played a vital role in establishing the organization. She served the Foundation from 1994 to 2014 as an Hon'ble member of its General Body with utmost sincerity and dedication. We will always remember with gratitude the role she has played, both directly and indirectly, in the progress of the Foundation.

Executive Summary

The reporting period under review of the Annual Report i.e. July 2020-June 2021 was one of the most difficult times as we all had to pass through the horrible experiences of the 2nd wave of the Covid-19 which resulted in tragic loss of many precious lives across the country. This was a time of mourning, grieving and at the same time challenges and learnings too. During this dark and dreadful time, we have lost many of our closest and dearest, including members of our Governing Board, General Body and family members of our office staff. Though it's hard to say something affirmatively, a little good news is that vaccination has begun to take effect and by the end of 2021 the severity of both infections and deaths has begun to decline in the country.

The deadly virus has snatched away, one by one, the lives of our Hon'ble Board Member Khandaker Ibrahim Khaled, former Deputy Governor of Bangladesh Bank; mother of our Hon'ble Board Member Dr. Abdul Khaleq, Professor of Biochemistry and Microbiology at North South University; and Hon'ble Member of our General Body Dr. Nazma Chowdhury, Emeritus Professor of Dhaka University. At the end of April 2021, all the family members of our Accounts & Admin Manager Mr. Mahbub Raihan were infected with Corona. In just three weeks, he lost his beloved elder sister, his loving mother, and his beloved wife. On behalf of the Foundation, I pray to the Almighty for the eternal peace of the departed souls and extend my deepest sympathies to all living members of the bereaved families.

Apart from loss of precious lives, the pandemic impacted all aspects of our official work – from running programs, planning finances and collaborating with our partner & stakeholders across the country. Due to implementation constraints and financial limitations, we were compelled to put hold many of our Projects and Programmes.

Nevertheless, amidst these extreme adversities, we have tried our best to adapt with the situation and continue our core activities of "Talent Assistance Scheme (TAS)", besides keep running some potential supporting projects.

As per Audit Report for the period ended on 30th June, 2021 the Foundation had a Capital Fund of Tk.25,89,39,432/-. Total income and expenditure for the period were Tk.1,65,60,967/- and Tk.1,29,90,965/- respectively. The total project expenditure during the period was Tk.60,23,862/-. The total recurring administrative expenditure during the period was Tk.63,78,174/- only. The total non-recurring administrative expenditure during the reporting period was Tk.5,88,929/- only. The Accounts of the Foundation for the period of July 2020 to June, 2021, were audited by M/s. Toha Khan Zaman & Co., Chartered Accountants, Dhaka.

CHAPTER - I: ABOUT HUMAN DEVELOPMENT FOUNDATION

Introduction:

1. Human Development Foundation is a company limited by guarantee and licensed under Section 26 of the Companies Act, 1913. It was registered as a non-profit social welfare organization, by the Registrar of the Joint Stock Companies of Bangladesh on 29th November 1993. The objects for which the Foundation was established are, inter alia, the following:

"To set up, run or assist institutions of learning for imparting of knowledge, institutions for imparting technical and vocational skills, institutions for studies and research and for formal and non-formal education, institutions promoting human development and welfare, centres for medical aid and relief, homes for children, orphans and old people, maternity homes, homes for women and generally to promote welfare of the poor and relief of distress by social and welfare steps, to print and publish or assist in printing and publishing books, papers, scientific and useful works and adopt programmes and projects which may seem conducive to the attainment of the objects of the Foundation."

- x. Late Mr. Salah Uddin Ahmed, former Defense Secretary and Honorary Secretary General, Swanirvar Bangladesh.
 Late Mr. Alamgir M. A. Kabir was the first Chairman of the Foundation.

Source of Fund:

Finances of the Foundation have been built up with grants from the Ministry of Finance, Government of the Peoples' Republic of Bangladesh through budgetary allocations in the Fiscal Years 1993 -1994 and 1994 -1995. The Seed Fund has been kept in Fixed Deposits at different Banks/Financial Institutions and the Foundation has been functioning till date with the interests it earns from the Seed Fund investments.

Management of the Foundation:

As per Articles of Association of the organisation, a Governing Board, under the general control and supervision of a General Body, manages the affairs of the Foundation. The General Body is composed of all members of the Foundation with the proviso that the total number of members shall not exceed 27. And the Governing Board shall be composed of not more than 11 members. At present there are 18 members in the General Body and 9 members in the Governing Board. The term of the Board is for two years. Therefore, the election of the Board is held every alternate year. The Governing Board has the responsibility to determine the direction and scope of the activities of the Foundation. It also has the responsibility to approve projects and to approve and administer the annual and supplementary budgets. The Governing Board exercises full management and financial control of the Foundation. A list of the members of the General Body and that of the Governing Board is given at Appendix-B.

AGM & Meetings of the Governing Board:

The 26th Annual General Meeting (AGM) was held online on 27th January 2021. During the year under review, 03 (three) meetings of the Governing Board were held, in which, 16 agenda items were considered. Besides, 01 (one) meeting of the TAS Committee and 01 (one) meeting of the Board of Trustees, Human Development Foundation Employees' Contributory Provident Fund were also held.


CHAPTER-II: PROJECTS

1. Talent Assistance Scheme (TAS): TAS, the most significant programme of the Foundation, is directed with the aim of providing financial support in the form of interest free loan to underprivileged but meritorious students, mostly from rural areas. The scheme is significant in that it helps the disadvantaged talents to fulfill their cherished dream of continuing their education further after passing the SSC examination. Apart from providing financial support, the scheme is designed to help build leadership quality and instill moral values in them.

Every year 60 students (30 boys and 30 girls) from the Higher Secondary level are offered the award of interest-free loan. The assistance continues till the completion of their graduation degree. Each student, irrespective of academic group, receives Tk.1,150/- per month at HSC level. Under-graduate students of general discipline receive Tk.1,700/- per month, while those studying in technical disciplines (i.e. MBBS, Engineering, Agriculture) receive Tk.1,800/-. Interest-free loan is disbursed to the students in quarterly installments.

Each new TAS member receives a lump sum donation of Tk.1,000/- for the purpose of buying dress at the beginning of their enrollment in the Scheme. Moreover, donations for purchasing books and educational equipments are also provided to the students for every academic year. After two years at the end of their educational career they will have to repay their loans in 20 installments in 5 years.

TAS at present: A total of 1,541 students have so far been enrolled as members of TAS under 34 batches, starting from 1985. Among the total of 1,541 students, the number of current TAS members is 365. The number of passed-out (successfully completed graduation degree) students is 804 and the number of dropped-out students is 372.





Aziz-ul Huq Memorial Essay Competition

With an attempt to explore and nourish the talents of the TAS members, Human Development Foundation has been organizing Essay competition for the last six years. The purpose of the Essay Competition was to provide TAS students with an opportunity to demonstrate their writing skills, as well as express their views on current national issues.

As a tribute to HDF's ex-Chairman, this time the competition has been named as Aziz-ul Huq Memorial Essay Competition. As a part of procedure to this end, a 'Panel of Judges" was formed with two hon'ble members of the Board of the Foundation. The topic selected by the Governing Board was "বাংলাদেশের কৃষি উন্নয়নে পুরুষ ও নারী কৃষকের ভূমিকা" The TAS members were asked to submit their hand written essays in Bangla within 2,000 words. The competition was open for all current TAS members. In response, 48 numbers of write-ups were submitted to us before the dateline. Certificate, Crest and Prize Money were awarded to the first three winners based on final evaluation marks given by the panel of Judges.

2. Rural School Library Enrichment Programme (RUSLEP): The project was launched in 1986 with a view to build up libraries in rural schools with stocks of suitable books, other than the prescribed textbooks and to expose the students into the domain of education and enlightenment in which they are considerably disadvantaged as compared to their fellow students from urban background.

In achieving this goal, the schools under RUSLEP are supported with a substantial number of suitable books for school children, and the teachers who take care of the libraries are provided with short-term basic training on librarianship. Each and every year a large number of schools are phased out from the programme and the same number of schools are included in the programme to keep the number of schools at 100 every year. During the period under review, there are 100 schools under the programme.

- a) Library Activities: So far, from 1996 to 2018, Human Development Foundation has distributed 2,31,278 books to 520 schools libraries. Up to the period, 420 no. of school libraries have been established with well-stocked books. During the period under review, no books have been purchased or distributed among the schools due to fund constraint. The programme has been held up for the time being.
- 3. Women for Women: Women for Women is a pioneer non-government, non-profitable voluntary women's organization engaged in research and public education programmes on gender issues. The main objective of the organization is to raise women's voice and upgrade their overall status. It was established in 1973 by a group of committed women professionals. Since then, Women for Women has been engaged in research, advocacy awareness and motivational programmes. It has own resource centre with rich collection of materials on development and women issues. Publishing of Journals and Newsletters is one of the main functions of the organization. The Journals published by the Women for Women are enriched with information regarding women and many of

their important critical socio-economic issues with special focus on gender. It also provides information on national development focused on gender, up to date information and data on various issues on women collected from regular sources of statistics as well as paper clippings from home and abroad. So far it has published 130 books on research study and several reports on the workshops on women issues conducted by the group.

It has no permanent source of fund. The only 3 ways from which it collect fund are: 1. Annual fees and donations from members. 2. Sale proceeds from the Group's publications. 3. Fees collected from the library users.

"Women for Women" publishes two Journals annually on gender issues. The English Journal entitled EMPOWERMENT and Bengali Journal entitled KHAMOTAYAN. It also publishes Bengali version of Newsletter named NARIBARTA. Till to date twenty seven (27) issues of EMPOWERMENT and seventeen (17) issues of KHAMOTAYAN have been published. The journals published the recent research findings on issues concerning women's development. The published articles of the journals are very helpful in keeping people up date on the progress of women in Bangladesh and abroad. Several organizations provided support for the publications such as the PRIP Trust provided fund during the period 1994-1996, CIDA in 1998 provided fund for the journals and the Ford Foundation (1988-1991) and Asia Foundation (1996-1997) provided fund for the Newsletter. Besides, Women for Women utilized its own fund for the purposes also.

The Journals are generally distributed amongst different women's organizations, development organization, NGOs, research and educational organizations, women leaders, donor agencies etc. Besides, Journals, both English and Bengali version are sold @Tk.120/- each. Women for Women sent the copies of the above publications regularly to the HDF, which were circulated among the members of the HDF and to the schools under RUSLEP.

So far, HDF sanctioned a total amount of Tk.38,54,000/- (Taka Thirty Eight Lac Fifty Four Thousand) only to Women for Women from 2000-2020 for publication of Journals and Newsletters. During the period under review, HDF has sanctioned Tk.4,00,000/- (Taka Four Lac) only and disbursed a total amount of Tk.2,05,000/- (Taka Two Lac Five Thousand) only.

4. Tauri Foundation: Tauri Foundation, Dhaka has been running a special needs school called "School for Gifted Children (SGC)" for children with disabilities since 2004. Ms. Marufa Kabir, Director of Tauri Foundation, has got a baby girl, now grown up, with disability. She faced some difficulties to educate her daughter in conventional school and even in some special needs school earlier. Then she dreamt a dream to establish a school for children with disabilities. By the time she did a special course on education on disabilities.

As we know, about 10% (WHO statistics) of our total population is disabled. A report also reveals that 3% of children under 5 and 5% of children under 10 have disabilities. Unfortunately, only a few portions of the children with disabilities are being taught either under special education or in mainstream schools. Considering these facts in mind and for rendering services towards the children, Tauri Foundation started its journey to teach the children with disabilities and ultimately "School for Gifted Children" came to its existence.

The school first started with only its Dhaka premises. Children with disabilities such as autism, ADHD, Down syndrome, cerebral palsy, development and speech delay, intellectually disabled, hearing-impaired, blind etc. constitute the target students of the school. It has another centre in Rajshahi. The school first started with only 14 students, now the number of students has risen to 178 of which 92 in Dhaka School and 26 in Rajshahi School and 60 in rural area at Rajshahi. Tuition fees, donation from local & international philanthropist and corporate support help running the school. Usually, teacher and student ratio is about 1:1 in a special needs school, thus, the running cost of the school become higher than the mainstream school. Annual budget of Tauri Foundation which is usually made of taking local donation, corporate support and local & international philanthropist donation is not well enough to run the school sustainably. Thus, it approached to the Foundation for financial support. In response to its request, the Foundation awarded funding for the school. In total Tk.19,87,498/- (Taka Nineteen Lac Eighty Seven Thousand Four Hundred Ninety Eight) only was given during the years from 2010-2020. The last sanction was of Tk.2,50,000/- (Taka Two Lac Fifty Thousand) only for the period of July, 2019 – June, 2020. The fund was meant for meeting salary of three teachers; one Occupational Therapist, one Vocational Trainer and one Music Teacher. During the period under review, out of the sanctioned fund Tk.1,87,497/- (Taka One Lac Eighty Seven Thousand Four Hundred Ninety Seven) only has been released.

5. Society for the Welfare of Autistic Children (SWAC) Dhaka: Society for the Welfare of Autistic Children (SWAC), a non-profitable and non-government organization of Dhaka, has been working for the development and rehabilitation of the autistic children. The SWAC was formed by a group of enthusiastic parents of autistic children with a view to providing necessary education and training facilities to the autistic children so that they can become independent and self supportive instead of being a burden to society. At present the SWAC is providing diagnosis and assessment of autistic children, counseling of parents, education and giving package programme for development of them.

SWAC runs a school-cum training centre called the 'Dhaka Autistic Centre' in a privately rented house at Shyamoli, Dhaka. It has two separate sections of schooling, one for well off and the other is for underprivileged section. The student teacher ratio is about 1:1, which is very essential for autistic students. But it makes the curriculum very expensive for common people to afford. In view of the situation against their request, SWAC was given first sanction in 2006 from the Foundation. The first sanction was given for the purpose of purchasing toys, training materials for vocational training, first aid kits, and repair & maintenance cost of its school. The second and the subsequent sanctions were given to provide salary and bonus of teachers, student's conveyance, educational materials and medical allowance for under privileged section of its school. So far, a total of Tk.17,85,000/- (Taka Seventeen Lac Eighty Five Thousand) only has been given in eight separate sanctions starting from 2006 to June, 2020.

The Governing Board of the Foundation sanctioned an amount of Tk.3,00,000/- (Taka Three Lacs) only to them to run a new school of special education in Rangamati during 2019-2020. Out of the sanctioned fund, an amount of Tk.2,25,000/- (Taka Two Lac Twenty Five Thousand) only has been released for the purpose.

6. Concerned Women for Family Development (CWFD): Concerned Women for Family Development (CWFD), a non-governmental development organization, has been active in the field of Child and Mother Healthcare, Reproductive Health and Education since long. The organization has its head office in Dhaka and has project offices in different districts of Bangladesh. Though health and reproductive health are its focused fields of intervention, it has been running a school for slum children in Dhaka city. Bangladesh is committed to achieve education for all and to ensure 100% enrollment of children in school. But still poverty stricken section of people is left out of education. It needs extra effort to reach the poorest of the poor school aged children.

Poverty drives the poor people to urban areas like Dhaka for their subsistence. Some pull rickshaws or vans, some work as day laborer. Women work especially as domestic help. They reside in slums in inhuman condition. They are deprived of different fundamental needs like education, shelter, food, health etc.. To facilitate access to education to the urban poor children, CWFD initiated the school programme in its office premises from its own resources i.e. taking contribution from its Board members. The children are taught free of cost and educational materials are also provided free of cost. But for sustainable running of the programme it needs fund flow from outside. In view of the situation it approached to the Foundation for funding assistance.

In response to CWFD's appeal to the Foundation, it was awarded grant for an amount of Tk.2,18,850/- (Taka Two Lac Eighteen Thousand Eight Hundred Fifty) for the first time in 2008. Considering the project success, it was given further six sanctions for the purpose. In total Tk.29,63,777/- (Taka Twenty Nine Lacs Sixty Three Thousand Seven Hundred Seventy Seven) only was given in seven separate sanctions for the purpose from 2008 to 2021. The fund is meant for paying teacher's salary, cost of educational material, office stationeries and some administrative cost. The last, sanction for three years term, is for the period of January, 2019 – December, 2021.

The school, non-formal in nature, is set up in two rooms of its office premises. National curriculum is followed to teach the students. Apart from study, they are also encouraged to take part in different extra-curricular activities. A resource centre called "নিৰ্বার" has been in operation for the students having facilities of reading book, playing indoor games and enjoying cartoon film. Besides, imparting music lessons to 15 students, observation of World Children Day are among the extracurricular activities. Usually the students get admission into class I (one) and continue study up to class V (five). After completion of five years of schooling, they are facilitated to get admission into higher classes in nearby govt. schools. The report sent by the organization reveals that starting with only two classes back in 2003, now it has become to a full-fledged primary school, and has been running five classes with 73 students, out of which 17 in class I, 14 in class II, 14 in class III, 12 in class IV and 16 in class V. Conducting online classes, assign home-works, creating awareness among the children and their parents are being done sincerely during the Covid time. During the reporting period a total amount of Tk.4,11,980/- (Taka Four Lac Nine Thousand Eighty) only has been released in four (04) separate installments to implement the project.

7. Kobi Sikander Abu Zafar Foundation (KSAZF): Kobi Sikandar Abu Zafar Foundation (KSAZF), a development organization situated in Tetulia, Satkhira was initiated by Begum Nargis Jahan, widow of Kobi Sikandar Abu Zafar along with a group of educated local people, aiming at bringing about social change in community. After inception, KSAZF has been running different cultural and social development activities such as Kobi Sikandar Mela, library, non-formal primary education along with music school, one high school and tree plantation programme etc.

KSAZF has been implementing a project called "Ensuring Pre-primary Education to Help Underprivileged Children" with the financial assistance of the Foundation since 2009. The first project was implemented from September, 2009 to August, 2010. It was given further eight sanctions from the year 2011 to 2020. In total Tk. 21,45,080/- (Taka Twenty Nine Lac Forty Five Thousand Eighty) only was given in nine separate sanctions to the organization since 2009.

The aim of the project was to prepare children mentally, physically and psychologically to enter into the domain of education, cut down dropout rate and help them merge into the mainstream of education. The project area is under-developed, and have low literacy rate. Most of the people live below poverty level and are encircled by prejudices. Shrimp/fish culture which is the main occupation of the people of the location, leads to poorer agricultural activities; therefore food grain and livestock production etc. have come to a lower extent, which leads to food insecurity for the poorer section of people. Water logging at Kobadak has made the situation worst.

The one year long pre-primary education project is being implemented for proving basic education side by side music for making a joyful atmosphere for child education and cultural development. Parents were also made aware of social issues like education, early marriage, dowry etc. and were helped to come out of prejudices and to take part in development activities. 06 education centers with 180 students, 96 boys and 84 girls, and two music centers were run by the project during 2019-20. To carry out the activities of the project, 1 supervisor, 6 teachers and were deployed. As per project report, the achievement of the project is remarkable in terms of imparting quality preprimary education. The average class attendance is almost 98% and dropout rate from the centers is about 0%. After completion of the course, all the students are supposed to facilitate to get admission into nearby govt. primary school.

The Governing Board of the Foundation sanctioned an amount of Tk.2,50 Lacs/- (Taka Two Lacs Fifty Thousand) only to run the project during 2019-2020. During the reporting period and amount of Tk.1,72,000/- (Taka One Lac Seventy Two Thousand) only was released for implementation of the project.

- 8. Jano Shasthya Unnayan Sangstha (JSUS): Jano Shasthya Unnayan Sangstha (JSUS), Bagura, a development organization has been working in field of rural development since its inception in 2003. The organization is registered with the Department of Social Welfare. Dissemination of Bandhu Chula, tree plantation, health & nutrition are their main programmes and projects. Among the prgrammes and projects, Bandhu Chula (Improved Cook Stove-ICS), to mitigate climate change is their main programme. To popularize and dissemination of the stove, JSUS applied for funding assistance for a project titled "Popularization of Bandhu Chula Technology to reduce health hazards" to the Foundation. The goal of the project was to introduce fuel saving and low carbon emitting Bandhu Chula to reduce environmental hazards in kitchen to reduce health hazards. In response to their request the Foundation sanctioned an amount of Tk.2,56,000/- (Taka Two Lac Fifty Six Thousand) only for the period of July, 2019 – June, 2020 to implement the project. Salary of Chula Installer, Mason Training, 1 Advocacy meeting, Installation of 500 ICS and 500 saplings distribution were among the activities to be done by the project. During the reporting period, JSUS was given Tk.75,500/- (Taka Seventy Five Thousand Five Hundred) only.
- 9. **Ashraf Foundation**: Ashraf Foundation (AF), Jashore, a development organization, has been active in the field of rural development since 1992. AF is registered with the Department of Social welfare and NGO Affairs Bureau of Bangladesh. Vulnerable Group Development (VGD), education, disabled development programme training etc. are their main projects & programmes. AF was awarded a project titled "Help Access to Education to Children with Disabilities Establishing Special Needs School" aiming at imparting education to children with disabilities to make them human resources rather burden to society. An amount of Tk. 3,00,000/- (Taka Three Lac) only was given for this project for one year term i.e. from July, 2019 to June 2020 to impart special education to children with disabilities from class one to Class five. After completion of the five years of education, the students, eligible ones, are supposed to be facilitated to get admission into higher classes for inclusive education. AF, however, opened a school for disabled children in Chowgacha, a remotest part of the country, with the financial support from the HDF. Physically disabled, autistic, intellectually disabled, speech impaired children were the target group of the school. 20 children with different disabilities were enrolled in the school. Five teachers and 1 aya were deployed for the purpose. Apart from education the children were given assistive devices such as tricycle, hearing aid, and physiotherapy equipments with the financial support. During the reporting period Tk.2,46,700/- (Taka Two Lac Forty Six Thousand Seven Hundred) only was released to carry out activities of the school.

10. Voice & Views: Registered with the Department of Social Welfare and NGO Affairs Bureau, Voice & Views (V&V), Dhaka, a NGO, working with women and children with disabilities with a focus on burn caused disabilities. Ms. Jannatul Ferdouse, the Executive Director of the organization is a burn survivor. From her personal experience, she knows the agony of a burn survivor who undergoes bullying in educational institutions & workplaces and even in family. She intends to work with this issue. In this context, Voice and Views submitted a project proposal titled "Situation Analysis of Human Rights Issues of Burn Survivors Women of Bangladesh" to the Foundation. The project is about getting basic information of burn survivors' human rights issue.

The aim of the project was to assess the social issues pertaining of burn victims and carrying out some rehabilitation works of the victims depending on the finding of the study. An amount of Tk.2,50,000/- (Taka Two Lac Fifty Thousand) only was sanctioned in favour of the organization to implement the programme. V&V deployed two associate organizations to collect data/ information about the burnt survivors of two districts namely Narshingdi and Kushtia.

The project comprises of three steps. The first step is to look into the current socioeconomic condition of burn survivor specially women and the adversities in their everyday life because of burn affected physical situation. The proposed project is the first step of a three-step planned program. After getting the information of present situation, the next two steps would be: awareness development activities and the policy formation for burn survivor women and persons. The next two phase programs will be designed based on the information of the proposed project i.e. first phase of three-step project.

The following activities were carried out under the project: a) Community Meetings, b) Hospital Meetings and c) Conduct Individual Interviews. V &V, engaged two women headed organizations namely Mukti Nari O Shishu Unnayan Sangstha in Narshingdi and Jagoron Protibandhi Unnayan Sangstha (JPUS) in Kustia for the purpose. The survey was conducted with a standardized format and submitted to V&V. Information of 116 individual burn survivors have been collected, analyzed and disseminated. During the period under review, the entire sanctioned fund was released.

CHAPTER- III: ADMIN & ACCOUNTS

A. Administrative Affairs of the Foundation:

In the 26th Annual General Meeting held on 27th January 2021, Major General (Retd.) Prof. A. R. Khan, a Sponsor Member of the Foundation was unanimously elected Chairman of the Foundation for a period of 2 years.

Dr. Hamida Akhtar Begum, Ms. Khushi Kabir, Dr. Muhammad Abdul Mazid, Dr. Ayesha Banu, Prof. Abdul Khaleque, Prof. Zakir Hossain Raju all from Sponsor Category (Catagory-i); Ms. Syeda Rizwana Hasan, from the category of Private Organizations (Category-iv) and Dr. Rowshan Ara Firoz, from the category of Social Welfare Organizations (category-v) of the membership of the Foundation were elected as Members of the Foundation for two years.

Dr. Hamida Akhtar Begum, hon'ble member of the Governing Board, was unanimously elected as Honorary Treasurer of the Foundation for two years.

M/S Toha Khan Zaman & Co., Chartered Accountants, was appointed to audit the accounts of the Foundation for the period from 1st July, 2020 - 30th June, 2021.

At the end of the period under review, the Foundation had a team of 10 officers and supporting staff headed by the Executive Director as its Chief Executive Officer.

Accounts of the Foundation: The Accounts of the Foundation for the reporting period i.e. July 2020–June, 2021 were audited by M/s. Toha Khan Zaman & Co., Chartered Accountants, Dhaka. According to Balance Sheet, the total fund of the Foundation as on 30.06.2021 was Tk.25,89,39,432/- (Taka Twenty Five Crore Eighty Nine Lac Thirty Nine Thousand Four Hundred Thirty Two) only including its fixed assets, interest-free loan provided to the students under TAS, investment in different banks as FDR, advance and other current assets.

Total income and expenditure for the period of July, 2020-June, 2021 were Tk.1,65,60,967/- (Taka One Crore Sixty Five Lac Sixty Thousand Nine Hundred Sixty Seven) only and Tk.1,29,90,965/- (Taka One Crore Twenty Nine Lac NinetyThousand Nine Hundred Sixty Five) only respectively. Mentionable that during the reporting period the International Leasing could not provide accrued interest generated from our investment that's why income earning from our investment has fallen down.

The total project expenditure for the period of July, 2020-June, 2021 was Tk.60,23,862/- (Taka Sixty Lac Twenty Three Thousand Eight Hundred Sixty Two) only. The total recurring administrative expenditure during reporting period was Tk.63,78,174/- (Taka Sixty Three Lac Seventy Eight Thousand One Hundred Seventy Four) only. The total non recurring administrative expenditure during the reporting period was Tk.5,88,929/- (Taka Five Lac Eighty Eight Thousand Nine Hundred Twenty Nine) only.

At the end of the period under review, the total investment as 'Seed Fund' of the Foundation, in the various Financial Institution & Bank Accounts, stands at Tk.14,93,81,625/- (Taka Fourteen Crore Ninety Three Lac Eighty One Thousand Six Hundred Twenty Five). The Balance Sheet and the Income and Expenditure Account are given at Appendix-A.
